REACH Declaration

The new Regulation (EC) 1907/2006, REACH (Registration, Evaluation, Authorization and Restriction of Chemicals) came into force on 01 June 2007.

The purpose of REACH is:


- to improve the protection of human health and the environment from risks caused by chemicals.
- better risk management in the handling and processing of chemicals.
- to promote innovations and competitiveness in the chemical industry in the EC.

The REACH declaration contains the following regulations:

1. Manufacturers of chemicals, importers of chemicals as such or of chemicals in preparations in the European Community (EC) and the European Economic Area (EEA) must register these substances with the European Chemicals Agency beginning on 01 June 2008 if these are produced or imported in quantities of at least 1 ton per year and if these substances are not exempt from mandatory registration. So-called "phase-in substances", which include substances listed in the European Inventory of Existing Commercial Chemical Substances (EINECS) may be pre-registered in the period beginning on 01 June 2008 until December 2008. Depending on the production/import quantity, pre-registered substances do not have to be registered until a later time.
2. Suppliers of substances and preparations must provide either a safety data sheet (Art. 31) or safety information (Art. 32) to the purchaser. In specific cases, the safety data sheet will be supplemented by an annex indicating the relevant exposure scenarios ("extended safety data sheet").
3. Upon request, manufacturers and importers of products that contain a substance on the "candidate list" (Art. 33) in excess of 0.1% by mass per product must provide professional purchasers and consumers with sufficient information for the safe utilization of the product, or at least the name of the substance. In addition, if the substance is contained in all these products in a quantity in excess of 1 ton per annum, a report must be submitted to the European Chemicals Agency (ECHA), but no earlier than 01 June 2011.
4. "VIVA DECOR" LTD. manufactures products for you that are considered goods in terms of chemical legislation and are not defined as substances and/or preparations. According to REACH specifications, VIVA DECOR is a downstream user and is not subject to any registration obligations. The duties in accordance with no. 1 and no. 2 are therefore not applicable here.
5. "VIVA DECOR" LTD. hereby confirms that it does not use any substances currently on the "List of substances subject to authorization" (Annex XIV) in its products.

In our own interest and in that of our customers, we nonetheless continue to maintain a dialogue with our suppliers to ensure that all products delivered are registered in compliance with REACH.
